

Executive Board Meeting

March 1, 2018

Call to Order: President Terry Becker called the meeting to order at 1:00 p.m. at American Baptist East Church and welcomed everyone. In addition to the president, the following were in attendance: Brenda Beeler, Darlene Brockriede, Fred Bullinger, Pat Claybaugh, Steve Fritz, Judy Isaac, Walt Lewis, Diana Luck, Diane Meier, Don Mosbey, Fred Naab, David Pfettscher, Donna Schmidt, Sandra Schmidt, Tom Wiggers, and Lino Wiseman.

Acceptance of Agenda: Terry asked that today's agenda be accepted with flexibility.

Diane Meier made a motion to accept today's agenda with flexibility. Tom Wiggers seconded the motion. The board passed the motion unanimously.

Approval of Executive Board Minutes from December 7, 2017: The minutes were accepted as printed.

Officer Reports:

Treasurer: Lino Wiseman distributed a financial report as of December 31, 2017, which will be filed for audit. Lino also distributed several charts showing that our expenses for 2016 and 2017 were greater than our income. Board members discussed the situation and decided that the dues needed to be increased. David Pfettscher made a motion to raise dues to \$15 for teacher members. Judy Isaac seconded the motion. Tom Wiggers amended the motion to read that the board recommended raising the dues for teacher members to \$15. Judy Isaac seconded the amended motion. The amended motion passed unanimously.

(Note: Terry contacted board members by email after the meeting and asked about associate members. The response from board members was that dues for associate members should be increased to \$10.)

President-Elect: Walt Lewis announced the following slate of officer candidates: Steve Fritz for president-elect (2018/2019); Fred Bullinger, Don Mosbey, and Fred Naab for directors (2018-2020); and Sandra Schmidt for secretary (2018-2020). Steve Fritz will move up to president in the spring of 2019.

Immediate Past President: Tom Wiggers has selected ARC for the Special Project. Funds from the Special Projects account will be awarded at the luncheon in May. The exact amount is yet to be determined.

Committee Reports:

Community Service: Pat Claybaugh announced that ERTA members volunteered 31,051 hours last year. Of that total, 16,454 were for youth.

Fellowship: Judy Isaac reminded those in attendance to notify the committee if a card needs to be sent.

Membership: Darlene Brockriede reported that a few more memberships have been received.

Programs: Walt spoke about Dr. James MacLeod, who will speak on "Evansville During World War II" at next week's luncheon. Attorney Pat Shoulders will be our speaker in May.

Reservations: Diana Luck reported 138 reservations for next week's luncheon.

ISTA Legislative: Diane Meier said that next year there will be a big push for a COLA during the long session. It has been 11 years since members received a COLA.

Old Business: There was none.

New Business:

Report on the Hensley Scholarship: Diane Meier distributed a list of Hensley Scholarship recipients. A total of \$11,590 was awarded. The recipients and their projects are the following: Jane Elgin (Oak Hill), National Board Certification as an Early Childhood Generalist; Kimberly Elpers (North Junior High), Carnegie Melton Robotics Academy; Kellie Forney (Cynthia Heights) and Jenny Howard (Stringtown), Get Your Teach On Conference; Jane Gilbert (McGary), Art Education Association Conference; Kathy Heidorn (Bosse), School Climate and Culture Conference; Svitlana Reynolds (Itinerant ESL Teacher), School Climate and Culture Conference; Holly Thomas and Megan Bander (Oak Hill), I Teach K Conference; and Tim Wilhelmus (Technology and Innovation Center), Ed Camp Magic –Bringing creativity, STEM subjects, and brain-based learning together.

Sylvia Blice, Judy Isaac, Donna Lutz, and Donna Schmidt worked with Diane to determine the recipients and the amounts to be awarded.

Tom Wiggers made a motion to approve the list of recommended recipients. Don Mosbey seconded. The motion passed unanimously.

LST Proposal: Earl Pfetscher submitted a proposal about scheduling a tour of the LST. There was some discussion, but no decision was made.

Announcement: The next ERTA Executive Board Meeting will be Thursday, May 3, 2018.

Adjournment: David Pfetscher made a motion to adjourn the meeting. Fred Bullinger seconded the motion. The meeting was adjourned at 2:41 p.m.

Luncheon Meeting

March 8, 2018

Call to Order: President Terry Becker called the meeting to order at 12:05 p.m. at the American Baptist East Church Fellowship Hall. He welcomed those in attendance and asked that we invite members who haven't been coming to the luncheons.

Introduction of the Head Table: Terry introduced President-Elect Walt Lewis and Chaplain Ed Wessel. Walt introduced Dr. James MacLeod, a professor at the University of Evansville and today's speaker. His topic is "Evansville During World War II."

Pledge of Allegiance: Bob Rogers led members and guests in the Pledge of Allegiance.

Blessing: Chaplain Ed Wessel asked that we observe a moment of silence in memory of the 17 young lives lost recently in Florida. He then prayed and asked that we join him in reciting the Lord's Prayer.

Lunch Service: Walt dismissed those at the head table. Then, members and their guests were dismissed by tables.

Business Meeting:

Approval of December 14, 2017, Luncheon Meeting Minutes: The minutes were approved as printed.

Note of Thanks: Terry read a note of appreciation from The Salvation Army for ERTA's \$805 donation. The money was contributed by members and their guests who attended the December luncheon and meeting.

Dues: At last week's meeting, board members voted to increase the dues after learning that our expenses are greater than our income. The teacher member dues will increase to \$15, associate member dues to \$10. According to ERTA Bylaws, a vote must be taken at the spring meeting.

Installation of Officers: Terry reported that officer installation will take place at the next luncheon meeting. Walt announced the following slate of officer candidates: Steve Fritz for president-elect (2018/2019); Fred Bullinger, Don Mosbey, and Fred Naab for directors (2018-2020); and Sandra Schmidt for secretary (2018-2020). Steve Fritz will move up to president in the spring of 2019.


Information: Terry said that there is a possibility that a tour of the LST could be scheduled.

Door Prizes: Drawings were held for three \$10 Starbucks gift cards.

May Program: Attorney Pat Shoulders will be the speaker.

Today's Program: Dr. James MacLeod spoke about the transformation of Evansville for the war effort. Fifty to seventy companies switched to producing war materials. In addition, two new industries sprang up within a matter of months; one built the Landing Ship Tanks and the other built P-47 Thunderbolts.

Dr. MacLeod also spoke about how the number of industrial workers in prewar Evansville, about 18,000, increased to 60,000-80,000 at the peak of the war. Additional housing was built by the federal



government to help house the influx of workers. He added that this was a transformational time for women and the black population because they began working in the factories.





At the end of his presentation, Dr. MacLeod noted that there is an Evansville Wartime Museum.
