Everything else aside, these brave and wonderful people have made me change the way I answer the question, “So, what are you doing with your time?” From now on my answer is a proud, “Any _____ thing I want!” I hope you do the same!! AND come to the October 12 luncheon! Gina Moore is going to help us celebrate, and “A good time will be had by all!!”

Message from Our President-Elect, Walt Lewis

As we approach another Veterans Day, a thought comes to mind

Until recently, all of us could recall family members, neighbors, teachers, and other acquaintances who served or were serving in the American armed forces. Seemingly, everyone was connected as young men and women served our country as volunteers or draftees. Their contribution was always appreciated; and, during times of war, we feared for their safety. We were well aware of the significance of a blue or gold star in a neighbor's window.



The tri-state was a hub of military activity with every military branch represented by local reserve units. The Army National Guard units were always present when needed to serve our community, and active duty soldiers from Fort Campbell, Camp Breckenridge, and Fort Knox frequented downtown Evansville on weekend passes. Evansville was home to an active group of military and former military personnel who sponsored parades and celebrations on patriotic holidays. Evansville was the site of the world's largest VFW club and home to numerous American Legion and veterans' clubs and known nationwide as a patriotic and military supportive community.

Circumstances, however, have changed significantly in the last several decades. With the end of the draft and with fewer young men and women serving in our armed forces, many of us do not personally know a member of the active military. We seldom hear or read about the continued contributions made by American service men and women. These men and women serve repeated tours of duty in areas of hostility, resulting in extensive casualty lists and increasing the risk of PTSD. A small blurb in the paper or casual mention on the evening news stirs very little interest or workday discussion. Military personnel in uniform are seldom seen in our stores and restaurants, and service clubs struggle to gain new members and to stay operational.

Have we lost something of value, or is this a positive step away from "militarism"? American service members still serve in hundreds of overseas installations. Parents, spouses, and dependent children still miss family members and fear for their safety. None of us, however, fears a child or relative being drafted and sent to serve in some forsaken jungle or frozen Arctic installation. Someone else's child, spouse, or sibling does that job. It really seems to have little to do with our lives and generally does not create fear for the safety of those we love. Surely, we do not need an international conflict of the magnitude of a world war or a Vietnam war to generate that deep respect and love for America's warriors, past and present.

August 3, 2017**

Call to Order: President Terry Becker called the meeting to order at 1:03 p.m. at the American Baptist East Church. In addition to the president, the following were in attendance: Darlene Brockriede, Fred Bullinger, Andy Guarino, Walt Lewis, Diana Luck, Diane Meier, Don Mosbey, Fred Naab, Darla Olberding, Tom Wiggers, and Lino Wiseman.

Acceptance of Agenda: Terry asked that the agenda be accepted with flexibility. Diane Meier made the motion to accept and Tom Wiggers seconded. The motion passed.

Approval of Board Minutes from May 4, 2017: The minutes were accepted as printed.

Officer Reports:

Treasurer: Lino Wiseman distributed the final 2016-2017 financial report. The balance in the general fund is \$980.70. The remaining \$358.69 from the Special Projects line item will be spent on Friday, August 8 to provide breakfast at McDonald's for the AIS staff.

Lino stated that both state and federal tax forms have been submitted.

Lino has been receiving bogus e-mails with the names of board members requesting money to pay bills. Fortunately, he recognized the scam and did not pay!

Dues for the 2017-2018 are starting to arrive. He reminded everyone to pay!

President-Elect: Walt Lewis has checked with six (6) different catering services. The meal in August will be catered by Wolf's Bar-B-Q and the Carousel will cater the October luncheon.

Walt announced that a Signature School graduate Melanie Baker has been invited to the August luncheon. She is the recipient of an IRTA scholarship. She will be attending the University of Evansville.

The program for the August luncheon will be Stan Levco, former Vanderburgh County Prosecutor. Walt will provide the program in October. Pat Shoulders is scheduled for May. The program for March has not been decided. Anyone who has a program suggestion should contact Walt.

Various non-profits have contacted Walt in regards to getting volunteers for their activities. Our rule is that they may come to a meeting, set up a display, and talk to members individually about volunteering. SWIRCA and the Girl Scouts indicated they would be at the August meeting.

Immediate Past President: Tom Wiggers did not have a report but did thank the members for the cards he received after his surgery.

President: Sandra Schmidt is recovering from a fall and is not able to chair the "Welcome Back to School Candy Baskets." President Terry Becker will chair the event with lots of help and advice from Sandra. The baskets will be filled and delivered to the schools on Monday, August 7. Terry asked for volunteers.

Committee Reports:

Audit/Budget: Darla Olberding reported that the financial books were reviewed on July 28 and found to be in good order.

Fellowship/Necrology: Diane Meier reported that Judy Isaac, chair of this committee, is in the hospital. Diane will be sending cards to members until Judy is ready to take over again.

Membership: Darlene Brockriede reported that six (6) newly retired teachers will be our guests at the August luncheon. She also stated that she is still trying to find phone numbers for some of the newly retired teachers.

Publications: It was noted that the website needs some updating.

Reservations: Diana Luck reported that she has received 166 reservations for the August luncheon.

Special Projects: In the treasurer's report it was noted that Brenda Weber would be using any left over money from this account to purchase breakfast for the AIS staff on August 8. After that, if there are remaining funds, those funds will be given to the school to purchase refreshments for a staff meeting.

Tom Wiggers, immediate past president, is still deciding on the activity he will recommend this year.

Legislative: Diane Meier reported that the legislature passed a bill so that retired teachers will receive a "13th check" for the next two years. The IRTA Legislative Committee has to continuously lobby legislators for a COLA or 13th check.

Frog Follies: Jim Sharp is coordinating the volunteers for the August 25-26 event.

Old Business: There was none.

New Business: There was none.

Information Items: Andy Guarino is the IRTA Regional Director for District 9. He reported that the fall workshop would be in Montgomery, Indiana at the Gasthof Restaurant on October 4 from 9:00 a.m. to 4:00 p.m. The state will pay mileage for one (1) car and a second one if needed. The state also will provide lunch for the participants. Andy needs the reservations by September 1.

IRTA membership is approximately 22,000 including both regular and associate members. Regular membership is under 20,000. Andy stated that the goal is to have 25,000 members by 2020.

Lunch Reservations: Terry explained that if a reservation is cancelled after the cut-off date, payment still needs to be made.


President-Elect:


Door Prizes: Names were drawn for the three gift cards that were awarded.
