Executive Board Meeting

December 1, 2016

Call to Order: President-Elect Terry Becker called the meeting to order at 1:00 p.m. at American Baptist East and welcomed everyone. In addition to the president-elect, the following were in attendance: Brenda Beeler, Darlene Brockriede, Fred Bullinger, Judy Isaac, Diana Luck, Diane Meier, Don Mosbey, Fred Naab, David Pfettscher, Ed Rusk, Brenda Scheidler, Sandra Schmidt, Brenda Weber, and Lino Wiseman.

Meditation: Chaplain Ed Rusk read "Living Would Be Easier If Men Showed As Much Patience at Home As They Do When They're Fishing." Then, he read 1 Peter 3:7 and prayed.

Acceptance of Agenda: Terry asked that today's agenda be accepted with flexibility. Diane Meier made a motion to accept today's agenda with flexibility. Brenda Weber seconded the motion. The motion passed unanimously.

Approval of October 6, 2016 Executive Board Minutes: The minutes were accepted as printed.

Officer Reports:

Treasurer: Lino Wiseman distributed the financial report for October 31, 2016. There was no discussion. It was noted that the savings and checking accounts earned 64 cents in interest.

President-Elect: Terry announced that Tom arranged for the Carousel to cater our meal at next week's luncheon. A discussion will take place after the luncheon to determine if we should stay with the Carousel or seek another caterer.



Immediate Past President: Brenda Weber reported that she has not yet selected the special project for the end of the year, but she does know that she wants it to be school based.

Brenda suggested that we do something for the custodian at the church because of all the extra work he has to do for our luncheons. She made a motion to give the church custodian \$100 at the Christmas meeting. David Pfettscher seconded the motion. The motion passed unanimously.

Committee Reports:

Community Service: Diane Meier spoke for Jan Kraft and reminded the board members that volunteer hours are due at the end of December.

Membership: Darlene Brockriede informed the board that ERTA currently has 315 members. Of that number, 223 retired teachers and 18 associate members have paid. Those who don't pay dues include first-year retired teachers, an honorary member, and 19 ERTA past presidents. Teacher retirees numbered 54 this year.

Nominations: Terry listed the positions on the board that will need to be filled for 2017/2018. The positions include president-elect, chaplain, reservations, and publicity.

Reservations: Diana Luck reported 179 reservations for next week's luncheon.

Publicity: Judy Isaac said that she sent information to the newspaper about our December luncheon. The paper did print the information.

Scholarships: Diane Meier announced that the deadline for applying for the Hensley will be in February. The scholarships will be awarded in March.

IRTA/Legislative: Diane Meier spoke about the importance of supporting the work of IRTA. As more retire, more will draw from the fund. At one point our pension will not keep up with inflation. Our pension fund is an unfunded liability. When Mitch Daniels was governor, he did pay back some of what was owed. Diane added that we would not have gotten the last stipend without Vaneta Becker.



Our pension check for January will arrive on the third of the month.

Old Business: There was none.

New Business: The board was asked to consider the new ERTA logo created by Jon Siau. After some discussion, Brenda Weber made a motion to accept the new logo if there were no copyright concerns. David Pfetscher seconded the motion. The motion passed unanimously.



Brenda asked the secretary to send a thank you note to Jon.

Announcement: The next board meeting will be March 2, 2017.

Adjournment: The meeting was adjourned.

The center was formed in 1981.

Community Engagement Director Rachel Gumble spoke about group volunteer opportunities at the center and announced that a monthly skills workshop will be starting soon. She concluded by saying that the response program operates 365 days a year.

Christmas Project: Tom asked members to make a contribution to the Albion Fellows Bacon Center. Contributions were to be placed in the Christmas gift bag that was on each table.

Volunteer Hours: Tom reminded members to e-mail their volunteer hours to Jan Kraft by the end of December.

Lunch: Those seated at the head table were dismissed for meal service, followed by members and guests.

Approval of October 13, 2016 Luncheon Minutes: The minutes were approved as printed.



Door Prizes: Poinsettias provided by the board were awarded as door prizes.

Program: The North High School Varsity Singers, under the direction of Nicholas Gray, provided the entertainment for today's luncheon meeting. The a cappella choir sang a variety of Christmas carols. The program was held in the sanctuary.



Legislative News, Diane Meier

There were three COLA bills submitted and none have surfaced in committee. Tom Mellish, IRTA Executive Director, has indicated that these bills won't be brought forward. Two "13th Check" Bills were filed, HB 1537, Rep. Gutwein's bill was brought forward last week and passed the House Employment, Labor and Pension Committee by an 11-0 vote. It will go on to the House Ways and Means Committee. Presently, House Bill 1537 has passed in the house; it provides for a 13th check, with no increase in the amount. However, House Bill 1246 which provides a 2% COLA has not been heard. Even though HB 1537 is a straight "13th Check" Bill, no increase, IRTA has testified in favor, but asked that an increase be included.

Please continue to write your legislators urging the passage of a COLA or at least an increase in the 13th check; talking points you can use:

- Teachers have not received a COLA since 2007.
- Prices, especially for medical needs and utilities, have continued to increase.
- If the gas tax is raised, it will put an additional hardship on seniors who have a fixed income.
- Use personal stories of how you/your family have been affected by the increase in prices.

April 4 is the Legislative Brunch in Indianapolis. It begins at 9:00 in the Statehouse; please plan to attend.
