AUGUST IRTA (INDIANA RETIRED TEACHERS) FOUNDATION

At our District 9 summer meeting, Andy and Brenda had the opportunity to learn more about the state association and what benefits it provides to the members. Following are items which are certainly worth noting.



PROGRAMS – The following programs are operational or in the process of being developed:

SCHOLARSHIPS – The Scholarship Committee is led by Barb Stroud. It awards one scholarship in each IRTA area. The scholarship is for a junior or senior in college who has been accepted into the School of Education, in the state of Indiana, and is a son or daughter, grandson or granddaughter, legal dependent, or spouse of an active, retired, or deceased member of the Indiana State Teachers' Retirement Fund (TRF). The scholarship is for \$5,000. Two districts in the state of Indiana did not have anyone apply for the scholarship this past year. In our District 9, Dubois County has received the scholarship the past two years. Applications must be received by IRTA on or before January 31, 2015. The applicant must have achieved at least a "C" grade point average over three (3) semesters in an Indiana college or university to be eligible to apply.

A HAND UP – Sally Klingerman leads this committee as it seeks to provide assistance to IRTA members experiencing a financial hardship. This is a great opportunity for a local RTA to assist a fellow educator in need who may not be aware of the program. If you know of someone in our local association who is in need, talk with Andy Guarino or Brenda Weber regarding this program.

TEACHER GRANTS – This program is in development. Our past president, Bob Suhrheinrich, is leading a committee in drafting a program to provide one-time grants to active teachers. This program should be a great way to support active teachers and for them to become more aware of IRTA and their local RTA.

COMMITTEE GRANTS – This program is just in the discussion stage. Its purpose would be to provide one-time grants to IRTA committees to assist them in fulfilling their missions. ERTA will stay on top of these grants and the possibilities they will provide to our local association.

Executive Board Minutes

August 7, 2014



Call to Order: President Andy Guarino called the meeting to order at 1:07 p.m. at the Phipps Center. In addition to the president, the following were in attendance: Brenda Beeler, Darlene Brockriede, Linda Hape, Diana Luck, Diane Meier, LaVonne Miller, Fred Naab, Jerry Noland, Darla Olberding, Ed Rusk, Sandra Schmidt, Linda Staley, Bob Suhrheinrich, Brenda Weber, Tom Wiggers, and Lino Wiseman.

Vacancies on the Executive Board: Darla Olberding made a motion to accept Brenda Weber as president-elect and Tom Wiggers as director. Diane Meier seconded the motion. The motion passed unanimously.

Meditation: Chaplain Ed Rusk read "You Don't Have to Lie Awake Nights to Succeed – Just Stay Awake Days." Then, he read John 9:4 and prayed.

Approval of May 1, 2014 Executive Board Minutes: Lino Wiseman made a motion to accept the minutes. Diane Meier seconded the motion. The minutes were accepted as presented.

Officer Reports:

Treasurer: Lino distributed the 2013/2014 Year-end Report and the 2014 Proposed Budget. He called our attention to the highlighted items on the year-end report. Some were better than projected; others were worse than expected. The money remaining in Special Projects (\$1,235.00) was transferred to the Hensley Scholarship Fund at the request of then Immediate Past President Gene VanStone. ERTA received \$1,135.00 this past year from ETFCU employees, so the surplus of \$2,038.16 at the end of the year was transferred to the Hensley to keep the checking account under \$2,000.00.

Currently, Special Projects has \$6.16, the checking account has \$1,999.24, and the savings account has \$239.30. The total amount in the Hensley accounts is \$54,253.65. About \$10,000 each year is spent out of the Hensley. The Indiana tax form and the IRS tax form were submitted in July and accepted. Darla Olberding made a motion to accept the 2014 Proposed Budget. Bob Suhrheinrich seconded the motion. The motion passed unanimously.

President-Elect: Brenda Weber reported that Indiana State Superintendent of Public Education Dr. Glenda Ritz will be speaking at next week's luncheon while we are eating due to her schedule. Other speakers this year will be Evansville ARC President Deidra Conner in October, Evansville Police Chief Billy Bolin in March, and the current IRTA Executive Director Nancy Tolson in May. A middle school or high school choir will perform at the meeting in December.

Committee Reports:

Auditing and Budget: Darla reported that the books were audited on July 31, 2014. They were found to be in order.

Fellowship/Necrology: Linda Hape announced that six teachers have passed away since the newsletter was sent. Several members of the Executive Board gave Linda Staley names of those who should receive get-well cards.

Membership: Darlene Brockriede said dues are to be paid by October 31, 2014. The membership list will be purged at the end of October.

Nominating: Brenda asked those in attendance to contact her if anyone knew of a member who would like to be an officer.

Publications/Newsletter: Andy informed the Executive Board that the newsletter must be no longer than ten pages to eliminate the need for extra postage.

Website: The website needs to be updated.

Reservations: Diana Luck reported 204 reservations at this time for the luncheon. Thirty-one are for new retirees.

Scholarships: Diane explained that the scholarship at UE and the one at USI are awarded in the spring to students majoring in education. The Hensley scholarships are awarded in the winter to those currently teaching.

IRTA/Legislative: Diane said that those retired for a year will receive a stipend in September. IRTA will continue to lobby for a COLA.

Historian: Darla has been clipping articles about retired teachers from the newspaper.

Frog Follies: Lots of members have signed up to help, but some spaces are still available,

Information:

Directors' Terms: Andy reviewed the terms of the six directors.

Helping Hand Project: Andy informed the Executive Board that he plans to name a committee for this project, which was initiated by IRTA. The intent of the IRTA program called "A Hand Up" is to give one-time help to retired teachers who are struggling financially due to an unexpected hardship.

Welcome Back Baskets: A basket containing candy and ERTA bookmarks was delivered to each EVSC school by five teams of retired teachers this morning.

Employment and Volunteer Opportunities: Information about several employment and volunteer opportunities will be available at the luncheon.

October Luncheon: Those attending the luncheon will be asked to wear school spirit clothing.

Christmas Project: Evansville ARC will be this year's project.

Announcements:

Awards at the IRTA Representative Assembly: Immediate Past President Bob Suhrheinrich reported the following: Outstanding Volunteer - Diane Meier, Outstanding Volunteers (Honorable Mention) – David Pfetscher and Laurel Vaughn, Outstanding Group Project – High School Art Teachers Reception, and Outstanding Media - ERTA newsletter, press releases, and website.

ERTA received a personal check from Sudesh Naraine for \$350 because our association had the most membership growth.

Adjournment: At 2:35 p.m. Brenda Weber made a motion to adjourn. Bob seconded the motion.

The meeting was adjourned.
